ARTICLE I INTRODUCTORY PROVISIONS

Section 101. <u>Title</u>

This ordinance shall be known and may be cited as <u>Subdivision</u> <u>Ordinance</u> of the Town of Turkey, North Carolina and may be referred to as the <u>Subdivision</u> <u>Ordinance</u>.

Section 102. Purpose

The purpose of this ordinance is to establish procedures and standards for the development and subdivision of land within the territorial jurisdiction of Town of Turkey. It is further designed to provide for the orderly growth and development of the Town; for the coordination of transportation networks and utilities within proposed subdivisions with existing or planned the streets and highways and with other public facilities; for the dedication or reservation of recreation areas serving residents of the immediate neighborhood within the subdivision and of rights-of-way or easements for street and utility purposes; and for the distribution of population and traffic in a manner that will avoid congestion and overcrowding and will create conditions that substantially promotes public health, safety and the general welfare. This ordinance is designed to further facilitate adequate provision of water, sewerage, parks, schools, and playgrounds, and also to facilitate the further re-subdivision of larger tracts into smaller parcels of land.

Section 103. <u>Authority</u>

This ordinance is hereby adopted under the authority and provision of the General Statutes of North Carolina, Chapter 160D, Article 8.

Section 104. <u>Jurisdiction</u>

The regulations contained herein, as provided in G.S. 160D, Article 8 shall govern each and every subdivision within the Planning & Development Regulation Jurisdiction of Turkey.

Section 105. <u>Prerequisite to Plat Recordation</u>

After the effective date of this ordinance, each individual subdivision plat of land within the Town's jurisdiction shall be approved through an evidentiary hearing and quasi-judicial process as provided herein by the Board of Commissioners or administratively by the Administrator.

Section 106. <u>Thoroughfare Plans</u>

When a proposed subdivision includes any part of a thoroughfare which has been designated as such upon the officially adopted thoroughfare or comprehensive plan of the Town, and part of such thoroughfare which has been designated as such upon the officially adopted thoroughfare plan of the Town, such part of such thoroughfare shall be plated by the subdivider in the location shown on the plan and at the width specified in this ordinance.

Section 107 School Sites on Comprehensive Plan

Per G.S. 160D-804, the reservation of school sites may be provided as approved by the Board of Commissioners. In order for this authorization to become effective, before approving such plans, the Board of Commissioners and the Board of Education with jurisdiction over the area shall jointly determine the location and size of any school sites to be reserved. Whenever a subdivision is submitted for approval that includes part or all of a school site to be reserved under the plan, the Board of Commissioners shall immediately notify the board of education and the board of education shall promptly decide whether it still wishes the site to be reserved. If the board of education does not wish to reserve the site, it shall so notify the Board of Commissioners and no site shall be reserved. If the board of education does wish to reserve the site, the subdivision shall not be approved without such reservation. The board of education shall

then have 18 months beginning on the date of final approval of the subdivision within which to acquire the site by purchase or by initiating condemnation proceedings. If the board of education has not purchased or begun proceedings to condemn the site within 18 months, the landowner may treat the land as freed of the reservation.

Section 108. Compliance with Zoning Ordinance and Other Plans

Proposed subdivisions must comply in all respects with the requirements of the zoning ordinance in effect in the area to be subdivided, and any other officially adopted plans.

ARTICLE II

LEGAL PROVISIONS

Section 201. General Procedure for Plat Approval

After the effective date of this ordinance, no subdivision plat of land within the Town's planning and development regulation jurisdiction shall be filed or recorded until it has been submitted to and approved by the Town as set forth in this ordinance, and until this approval is entered in writing on the face of the plat as provided herein.

The Sampson County Register of Deeds shall not file or record a plat of a subdivision of land located within the planning and development regulation jurisdiction of the Town of Turkey that has not been approved in accordance with these provisions, nor shall the Clerk of Superior Court order or direct the recording of a plat if the recording would be in conflict with this section.

Section 202. <u>Statement by Owner</u>

The owner of land shown on a subdivision plat submitted for recording, or his authorized agent, shall sign a statement on the plat stating whether or not any land shown thereon is within the planning and development regulation jurisdiction of Town of Turkey, North Carolina.

Section 203. Effect of Plat Approval on Dedications

Pursuant to G.S. 160D-806, the approval of a plat does not constitute or effect the acceptance by the Town or public or the dedication of any street or other ground, public utility line or other public facility shown on the plat and shall not be construed to do so.

Section 204. Penalties for Violation

204.1 After the effective date of this ordinance, any person who, being the owner or agent of the owner of any land located within the planning and development regulation jurisdiction of this ordinance, thereafter subdivides his land in violation of this ordinance or transfers or sells land by reference to, exhibition of, or any other use of a plat showing a subdivision of the land before the plat has been properly approved under the terms of this ordinance and recorded in the Office of the Sampson County Register of Deeds, excepting the presale or pre-lease of unrecorded lots referencing an approved preliminary plat and subject to the requirements of subsections 306.4, shall be guilty of a misdemeanor. The description by metes and bounds in the instrument of transfer or other document used in the process of selling or transferring land shall not exempt the transaction from this penalty. The town may bring an action for injunction of any illegal subdivision, transfer, conveyance, or sale of land, and the court shall, upon appropriate findings, issue an injunction and order requiring the offending party to comply with the subdivision regulation.

204.2 The violation of any provision of this ordinance shall subject the offender to a civil penalty in the amount of \$50.00 to be recovered by the Town. Violators shall be issued a written citation which must be paid within ten (10) days.

204.3 Each day's continuing violation of this ordinance shall be a separate and distinct offense.

204.4 Notwithstanding Subsection 204.2 above, this ordinance may be enforced by appropriate equitable remedies issuing from a court of competent jurisdiction.

- 204.5 The Town may cause building permits to be denied for lots that have been illegally subdivided.
- 204.6 Building permits required pursuant to G.S. 160D-1110 may be denied for lots that have been illegally subdivided.
- 204.7 Nothing in this section shall be construed to limit the use of remedies available to the Town. The Town may seek to enforce this ordinance by using any one, all, or a combination of remedies.
- 204.8 In addition to other remedies, the Town may institute any appropriate action or proceedings to prevent the unlawful subdivision of land, to restrain, correct or abate the violation or to prevent any illegal act or conduct.

Section 205. <u>Separability</u>

Should any section or provision of this ordinance be decided by a court of competent jurisdiction to be unconstitutional or invalid, such decision shall not affect the validity of the ordinance as a whole or any part thereof other than the part so declared to b unconstitutional or invalid.

Section 206. Variances

The Turkey Board of Adjustment may authorize a variance through an evidentiary hearing and quasi-judicial decision from these regulations when, in its opinion, undue hardship may result from strict compliance. In granting any variance, the Board of Adjustment shall make the findings required below, taking into account the nature of the proposed subdivision, the existing use of land in the vicinity, the number of persons to reside or work in the proposed subdivision and the probable effect of the proposed subdivision upon traffic conditions in the vicinity. No variance shall be granted unless the Board of Adjustment finds all four of the following findings are met:

- a. Unnecessary hardship would result from the strict application of the regulation. It is not necessary to demonstrate that, in the absence of the variance, no reasonable use can be made of the property.
- b. The hardship results from conditions that are peculiar to the property, such as location, size, or topography. Hardships resulting from personal circumstances, as well as hardships resulting from conditions that are common to the neighborhood or the general public, may not be the basis for granting a variance. A variance may be granted when necessary and appropriate to make a reasonable accommodation under the Federal Fair Housing Act for a person with a disability.
- c. The hardship did not result from actions taken by the applicant or the property owner. The act of purchasing property with knowledge that circumstances exist that may justify the granting of a variance is not a self-created hardship; and
- d. The requested variance is consistent with the spirit, purpose, and intent of the regulation, such that public safety is secured and substantial justice is achieved.

Section 207 Amendments

The Board of Commissioners may from time-to-time amend the terms of this ordinance in accordance with G.S. 160D-601. The Board of Commissioners may receive a recommendation from the Planning Board before approval of an amendment.

No amendment shall be adopted by the Board of Commissioners until they have held a legislative public hearing on the amendment. Notice of the hearing shall be published in a newspaper of general circulation in the Town of Turkey at least once a week for two (2) successive calendar weeks prior to the hearing. The initial notice shall appear not more than twenty-five (25) nor less than ten (10) days prior to the hearing date. In computing the ten (10) -- twenty-five (25) day period, the date of publication is not to be counted, but the date of the hearing is.

Section 208 <u>Development Moratoria</u>

The Town may adopt temporary moratoria on any Town development approval required by law. The duration of any moratorium shall be reasonable in light of the specific conditions that warrant imposition of the moratorium and may not exceed the period of time necessary to correct, modify, or resolve such conditions. A moratoria may be established through the procedure outline in G.S. 160D-107.

Section 209. Abrogation

It is not intended that this ordinance repeal, abrogate, annul, impair, or interfere with any existing easements, covenants, deed restrictions, agreements, rules, regulations, or permits previously adopted or issued pursuant to law. However, where this ordinance imposes greater restrictions, the provisions of this ordinance shall govern.

Section 210. Effective Date

This ordinance shall take effect and be in force from and after _____.

Section 211. <u>Adoption</u>

Section 212. <u>Administrator</u>

This ordinance shall be administered and enforced by an Administrative Officer [Administrator] or the designated representative who shall be named by the Board of Commissioners.

ARTICLE III PROCEDURE FOR REVIEW AND APPROVAL OF SUBDIVISION PLATS

Section 301. <u>Plat Shall Be Required on Any Subdivision of Land</u>

Pursuant to G. S. 160D, Article 8 a final plat shall be prepared, approved, and recorded pursuant to the provisions of this ordinance whenever any subdivision of land takes place.

Section 302. Approval Prerequisite to Plat Recordation

Pursuant to G. S. 160D-803, no final plat of a subdivision within the planning and development regulation jurisdiction of the Town of Turkey as established in this ordinance shall be recorded by the Register of Deeds of Sampson County until it has been approved as provided herein. To secure such approval of a final plat, the subdivider shall follow the procedures established in this article.

Plats not requiring approval as defined in Section 501, shall be submitted to the Administrator for certification that the final plat is EXEMPT from this ordinance. The following certificate shall be added to such exempt final plats:

a) Certificate of "No Approval Required." *This final plat is exempt from the Town of Turkey Subdivision Ordinance. No approval is required.*

Section 303. <u>Procedures for Review of Major and Minor Subdivision</u>

All subdivisions shall be considered major subdivisions except those defined as minor subdivisions in this Section. Major subdivisions shall be reviewed in accordance with the procedures in Section 305 through 307. Minor subdivisions shall be reviewed in accordance with the provisions in Section 304. However, if the subdivider owns, leases, holds an option on, or holds any legal or equitable interest in any property adjacent or located directly across a street, easement, road or right-of-way from the property to be subdivided, the subdivision shall not qualify under the abbreviated procedure. The abbreviated minor subdivision procedure may not be used a second time within three (3) years on any property less than fifteen hundred (1500) feet from the original property boundaries by anyone who owned, had an option on, or any legal interest in the original subdivision procedure may not be used within three (3) years on any property less than fifteen hundred (500) feet from the original property boundaries by any subsequent owner, individual having an option on, or individual having any legal interest in the original subdivision procedure may not be used within three (3) years on any property less than fifteen hundred (500) feet from the original property boundaries by any at the time the subdivision received preliminary or final plat approval. Furthermore, the abbreviated minor subdivision procedure may not be used within three (3) years on any property less than fifteen hundred (500) feet from the original property boundaries by any subsequent owner, individual having an option on, or individual having any legal interest in the original subdivision at the time the subdivision received preliminary or final plat approval.

A minor subdivision is defined as one involving no new public or private streets or roads, or right-of-way dedication, , no utility extension, where ten (10) or fewer lots result after the subdivision is completed.

Section 304. <u>Procedure for Review of Minor Subdivisions</u>

- 304.1 Reserved
- 304.2 Final Plat for Minor Subdivisions.

The subdivider shall submit a minor subdivision final plat, so marked, to the Administrator. Two reproducible copies and one paper copy shall be submitted. The final plat shall contain the required data as listed in Section 308. The minor subdivision final plat shall be prepared by a Registered Professional Land Surveyor or Engineer currently licensed and registered in the State of North Carolina. The minor subdivision final plat shall conform to the provisions for plats, subdivisions, and mapping requirements set forth in G.S. 47-30 and the <u>Standards of Practice for Land Surveying in North Carolina</u>; and, where applicable, the requirements of the Sampson County Register of Deeds. The minor subdivision final plat shall be of a size suitable for recording at a scale of not less then one (1) inch equal to two hundred (200) feet. The minor subdivision final plat may be placed on more then one sheet with appropriate match lines.

Submission of the minor subdivision final plat shall be accompanied by a filing fee .

The Administrator has up to seven (7) working days to review and approve the minor subdivision final plat. If errors or omissions are found, the subdivider shall be informed and the corrections made, and the final plat re-submitted for review a second time.

If the Administrator and subdivider can not resolve a question about the minor subdivision final plat, the Administrator shall forward the final plat and all information to the Board of Adjustment for an administrative appeal at the next meeting of the Board of Adjustment.

When approved for recording, the subdivider shall submit the signed minor subdivision final plat to the Sampson County Register of Deeds within ninety (90) days for recording; otherwise a new final plat will have to be submitted. The ninety (90) days starts with the date of the Administrators signature.

The following certificates shall appear on a minor subdivision final plat in substantially the same form:

a) Certificate of Ownership

I hereby certify that I am the owner of the property shown and described hereon, which is located in the planning and development regulation jurisdiction of the County of Sampson and that I hereby adopt this plan of subdivision with my free consent and establish minimum building setback lines as noted.

b) Certificate of Survey and Accuracy

c) Certificate of Approval for Recording

I hereby certify that the subdivision plat shown hereon has been found to comply with the Subdivision Regulations of the Town of Turkey, North Carolina and that this plat has been approved for recording in the Office of the Register of Deeds of Sampson County.

Section 305 Sketch Plan for Major Subdivision – Optional with Administrator

305.1 Number of Copies and Contents

Prior to the preliminary plat submission, the subdivider shall submit to the Town Clerk two (2) copies of a sketch plan of the proposed subdivision containing the following information.

- a) A sketch vicinity map showing the location of the subdivision in relation to neighboring tracts, subdivisions, road and waterways;
- b) The boundaries of the tract and the portion of the tract to be subdivided;
- c) The total acreage to be subdivided;
- d) The existing and proposed uses of the land within the subdivision and the existing uses of land adjoining it;
- e) The proposed street layout with approximate pavement and right-of-way width, lot layout size of lots;
- f) The name, address, and telephone number of the owner;
- g) The name, if any, of the proposed subdivision;
- h) Streets and lots of adjacent developed or plated properties;
- i) The zoning classification of the tract and of adjacent properties;
- j) A statement from the Sampson County Health Department that a copy of the sketch plan has been submitted to them, if a septic tank system or other onsite water or wastewater systems are to be used in the subdivision.

305.2 Submission and Review Procedure

The town clerk shall forward the sketch plan to the administrator who shall review it for general compliance with the requirements of this ordinance and the zoning ordinance; the Administrator shall advise the subdivider or his authorized agent in writing of the regulations pertaining to the proposed subdivision and the procedures to be followed in the preparation and submission of the preliminary and final plats.

One (1) copy of the sketch plan shall be retained by the subdivision administrator and one (1) copy shall be returned to the subdivider or his authorized agent.

Section 306. <u>Preliminary Plat Submission and Review</u>

306.1 Submission Procedure

Upon approval of compliance of the sketch plan, for every subdivision within the planning and development regulation jurisdiction, which does not qualify for the abbreviated minor subdivision procedure, the subdivider shall submit a preliminary plat which shall be reviewed in a preliminary forum by the Planning Board and approved by the Board of Commissioners before any construction or installation of improvements may begin.

Per G.S. 160D-301(b)(6), the Planning Board may provide a preliminary forum for review of on requests for major subdivisions provided that no part of the forum or recommendation may be used as a basis for the Board of Commissioners. The Board of Commissioners shall review through an evidentiary hearing and quasi-judicial decision per G.S. 160D-406 and shall determine contested facts and make its decision within a reasonable time.

No preliminary plat shall be approved by the Board of Commissioners unless it complies with the following findings of fact:

All applicable provisions and standards of this ordinance and the Town's zoning ordinance are met;
The plan provides adequate infrastructure (transportation, utilities, drainage, etc.) in accordance with this ordinance and other applicable local, state or federal requirements.

Every quasi-judicial decision shall be based upon competent, material, and substantial evidence in the record. Each quasi-judicial decision shall be reduced to writing, reflect the board's determination of contested facts and their application to the applicable standards, and be approved by the board and signed by the chair or other duly authorized member of the board. A quasi-judicial decision is effective upon filing the written decision with the clerk to the board or such other office or official as the development regulation specifies. The decision of the board shall be delivered within a reasonable time by personal delivery, electronic mail, or first-class mail to the applicant, landowner, and any person who has submitted a written request for a copy prior to the date the decision becomes effective. The person required to provide notice shall certify to the town that proper notice has been made, and the certificate shall be deemed conclusive in the absence of fraud.

306.2 Review by Other Agencies

Concurrent with submission of the preliminary plat to the town clerk, the subdivider shall submit copies of the preliminary plat and any accompanying material to other officials and agencies concerned with new development including but not limited to: the district highway engineer as to proposed streets, drainage systems; the Sampson County Health Director as to proposed water and sewerage systems; the North Carolina Department of Natural Resources and Community Development Land Quality Section as to the erosion control any other agency or official designated by the Board of Commissioners for review and recommendation. The administrator will advise the subdivider concerning which agencies are applicable for a given plat.

306.3 Review Procedure

The Board of Commissioners shall review the preliminary plat at an evidentiary hearing per Section 306.1.

The Board of Commissioners shall in writing, approve, conditionally approve or disapprove the preliminary plat.

When the Board of Commissioners approves a preliminary plat, such approval shall be in writing and noted on two (2) copies of the plat. One (1) copy of the plat shall be retained by the Town Clerk and one (1) copy shall be returned to the subdivider If the Board of Commissioners approves the preliminary plat with conditions, approval shall be noted in writing and on two (2) copies of the plat along with a reference to the conditions. One (1) copy of the plat along with the conditions shall be retained by the Town Clerk and one (1) copy of the preliminary plat along with the conditions shall be returned to the subdivider If the Board of Commissioners disapproves the preliminary plat due to not meeting the findings listed in this section, the reasons for such disapproval shall be specified in writing. One (1) copy of the plat and the reasons shall be retained by the Town Clerk and one (1) copy shall be returned to the subdivider.

If the preliminary plat is disapproved, the subdivider may make the recommended changes and submit a revised preliminary plat at any time. The revised preliminary plat submission shall follow the normal procedures outlined in this section.

Section 307. Final Flat Submission and Review

307.1 Preparation of Final Plat and Installation of Improvements

Upon approval of the preliminary plat by the Board of Commissioners, the subdivider may proceed with the preparation of the final plat, and the installation of or arrangement for required improvements in accordance with the approved preliminary plat and the requirements of this ordinance. Prior to approval of a final plat, the subdivider shall have installed the improvements specified in this ordinance or guaranteed their installation as provided herein. No final plat will be accepted for review by the Administrator unless accompanied by written notice by the Town Clerk acknowledging compliance with the improvement and guarantee standards of this ordinance when applicable. The final plat shall constitute only that portion of the preliminary plat which the subdivider proposes to record and develop at that time; such portion shall conform to all requirements of this ordinance.

307.2 Improvements Guarantees

A) Agreement and Security Required

Per G.S. 160D-804.1, in lieu of requiring the completion, installation, and dedication of all improvements prior to final plat approval the Turkey Board of Commissioners may enter into an agreement with the subdivider whereby the subdivider shall agree to complete all required improvements. The subdivider shall be allowed to choose which security or combination of securities that he/she wishes to provide from the choices provided below. The Town shall not have the authority to dictate which form of security will be accepted as an improvement guarantee, and shall be required to offer a range of options of types of improvements guarantees from which the subdivider may choose. Once said agreement is signed by both parties and the security required herein is provided, the final plat may be approved by the Administrator, if all other requirements of this ordinance are met. To secure this agreement, the subdivider shall provide, subject to the approval of the Administrator, either one, or a combination of the following guarantees not exceeding 1.25 times of the reasonably estimated cost of completion at the time the performance guarantee is issued.

- 1. Surety bond issued by any company authorized to do business in this State.
- 2. Letter of Credit issued by a financial institution licensed to do business in this State.
- 3. Other form of guarantee that provides equivalent security to a surety bond or letter of credit.

B) Default

Upon default, meaning failure on the part of the subdivider to complete the required improvements in a timely manner as spelled out in the performance guarantee, shall if requested by the Administrator, pay all or any portion of the performance guarantee to the Town of Turkey up to the amount needed to complete the improvements based on a certified engineering estimate. Upon payment, the Board of Commissioners, in its discretion, may expend such portion of said funds as it deems necessary to complete all or any portion of the

required improvements. The Town shall return to the subdivider any funds not spent in completing the improvements.

C) Release of Guarantee Security

The performance guarantee shall be returned or released, as appropriate, in a timely manner upon the acknowledgement by the town that the improvements for which the performance guarantee is being required are complete. The town shall return letters of credit or escrowed funds upon completion of the required improvements to its specifications or upon acceptance of the required improvements, if the required improvements are subject to town acceptance. When required improvements that are secured by a bond are completed to the specifications of the town, or are accepted by the town, if subject to its acceptance, upon request by the developer, the town shall timely provide written acknowledgement that the required improvements have been completed

307.3 Submission Procedure

The subdivider shall submit the final plat, so marked, through the town clerk and administrator at which it will be reviewed; further, the final plat for the first stage of the subdivision shall be submitted not more than twelve (12) months after the date on which the preliminary plat was approved; otherwise such approval shall be null and void, unless a written extension of this limit is granted by the Board of Commissioners through the vested rights provisions of G.S. 160D-108.1 on or before the twelve (12) month anniversary of the approval.

The final plat shall be prepared by a Professional Registered Land Surveyor currently licensed and registered in the State of North Carolina State Board of Registration for Professional Engineers and Land Surveyors. The final plat shall conform to the provisions for plats, subdivisions, and mapping requirements set forth in G.S. 47-30 and the Manual of Practice for Land Surveying in North Carolina.

Five (5) copies of the final plat shall be submitted; two (2) of these shall be on reproducible material; three (3) shall be black or blue line paper prints. Material and drawing medium for the original shall be in accordance with the <u>Manual of Practice for Land Surveying in North Carolina</u>, where applicable, and the requirements of the Sampson County Register of Deeds.

The final plat shall be of a size suitable for recording with the Sampson County Register of Deeds and shall be at a scale of not less than one (1) inch equals two hundred (200) feet. Maps may be placed on more than one (1) sheet with appropriate match lines.

Submission of the final plat shall be accompanied by a filing fee..

The final plat shall meet the specifications in Section 308 of this ordinance.

The following signed certificates shall appear on all five (5) copies of the final plat:

a) Certificate of Ownership and Dedication

I hereby certify that I am the owner of the property shown and described hereon, which is located in the planning and development regulation jurisdiction of the Town of Turkey and that I hereby adopt this plan of subdivision with my free consent, establish minimum building setback lines, and dedicate all streets, alleys, walks, parks, and other sites and easements to public or private use as noted. Furthermore, I hereby dedicate all sanitary sewer, storm sewer and water lines to the Town of Turkey.

b) Certificate of Survey and Accuracy

If the final plat is disapproved by the Administrator, the reasons for such disapproval shall be stated in writing, specifying the provisions of this ordinance with which the final plat does not comply. One (1) copy of such reasons and one (1) print of the plat shall be retained by the Town Clerk as part of its proceedings; one (1) copy of the reasons and three (3) copies of the plat shall be transmitted to the subdivider. If the final plat is disapproved, the subdivider may make such changes as will bring the final plat into compliance and resubmit same for reconsideration at anytime.

If the final plat is approved by the Administrator, the original tracing and one (1) print of the plat shall be retained by the subdivider. One (1) reproducible tracing and one (1) print shall be filed with the Town Clerk.

The subdivider shall file the approved final plat with the Register of Deeds of Sampson County within thirty (30) days of the Administrator's approval; otherwise such approval shall be null and void.

Section 309. <u>Recombination of Land</u>

Recombination plats shall follow the final plat checklist of this ordinance. Pursuant to G.S. 160D-802, the recombination of land is exempt from subdivision regulations. This pertains to the combination or recombination of portions of previously subdivided and recorded lots where the total number of lots is not increased and the resulting lots are equal to or exceed the standards of this ordinance and the Town of Turkey Zoning Ordinance. All lots created under this exemption must meet wastewater, area, and setback standards of the ordinance and Town of Turkey Zoning Ordinance. Recombination plats must adhere to requirements for recording per General Statues.

Section 310 Resubdivision Procedures

For any replatting or resubdivision of land, the procedures, rules, and regulations shall apply, as prescribed herein for an original subdivision.

Section 311 Probated Will Divisions

The division of a tract into parcels in accordance with the terms of a probated will or in accordance with intestate succession under Chapter 29 of the General Statutes shall be exempt from the requirements of the Town of Turkey Subdivision ordinance. Please note that all lots created must still adhere to Town of Turkey subdivision ordinance.

Section 312 Family Divisions

A division of land for family shall be exempt from the Town of Turkey subdivision ordinance, provided that the following standards are met:

- i. Lots adhere to the Town of Turkey Zoning Ordinance standards for the zoning district in which the parcels are located.
- ii. The property must not be in a corporate name (except for family corporations or corporate estate names).

- iii. The plat must indicate names of the family members and identify which lots are being conveyed to which family member. The relation of the family member must be noted on the plat. A family member may only be granted a maximum of three lots.
- iv. The statement "The lot(s) shown are created for the purpose of family ownership" must be noted on the plat. In instances where the division is proposed for deed of trust purposes, the statement shall read: "This plat is intended for deed of trust purposes and not for sale".
- v. Where lots are not adjacent to a public street, an access/utility easement must be shown with a note on the plat stating that the lot is benefited by a permanent easement for access and utilities. The easement must have a minimum width of thirty (30) feet. When a new easement is being established, the grantor must sign a dedication statement located on the plat. A note is required on the plat that a deed of dedication of the easement must be recorded with the Sampson County Register of Deeds.
- vi. It shall be noted on the plat "No additional lots, including resubdivision of the lots served by the access and utility easements, shall be permitted unless the access and utility easement is upgraded to meet or exceed the access standards for major subdivisions of the Town of Turkey Subdivision Ordinance.
- vii. The owner(s) of record at the time of recordation of the plat hall sign the following statement located on the plat: "The division of land is a family subdivision and is in no way intended to circumvent the provisions of the Town of Turkey Subdivision Ordinance. The lots shown are to be conveyed to the family members indicated on the plat. In instances where a division is proposed for deed of trust purposes, the second sentence shall read: "This plat is intended for deed of trust purposes and not for sale."
- viii. When an existing structure is within ten feet (10 ft.) of a required setback it must be shown on the plat with its respective distance.
- ix. There are to be no structures located within any recorded easement for access/utilities.
- x. Each family subdivision plat shall include the following notes:
 - 1. The existing septic system permit number(s) and the location of the system and repair area. When there is no existing septic permit the surveyor shall include a note that states this fact and indicate an approximate location.
 - 2. A soil scientist may sign the plat or a permit number for a proposed septic system may be included.
 - 3. The surveyor may note that the parcel is being conveyed as forestland or farmland and may be evaluated for septic at a later date before any residence may occupy the property.

ARTICLE IV REQUIRED IMPROVEMENTS, DEDICATION, RESERVATION, MINIMUM STANDARDS OF DESIGN

Section 401. General

Each subdivision shall contain the improvements specified in this article, which shall be installed in accordance with the requirements of this ordinance and paid for by the subdivider, unless other means of financing is specifically stated in this ordinance. Land shall be dedicated and reserved in each subdivision as specified in this article. Each subdivision shall adhere to the minimum standards of design established by this article.

Section 402. <u>Suitability of Land</u>

402.1 Land which has been determined by the Administrator or Board of Commissioners, on the basis of engineering or other expert surveys, to pose an ascertainable danger to life or property by reason of its unsuitability for the use proposed shall not be plated for that purpose, unless and until the subdivider has taken the necessary measures to correct said conditions and to eliminate said dangers.

402.2 Areas that have been used for disposal of waste shall not be subdivided unless tests by the Sampson County Health Department, a structural engineer and a soils expert determine that the land is suitable for the purpose proposed.

402.3

- a. All subdivision proposals shall be consistent with the need to minimize flood damage;
- b. All subdivision proposals shall have public utilities and facilities such as sewer, gas, electric and water systems located and constructed to minimize flood damage.

Section 403. <u>Name Duplication</u>

The name of the subdivision shall not duplicate nor closely approximate the name of an existing subdivision within the Town of Turkey and its extraterritorial jurisdiction area.

Section 404. <u>Subdivision Design</u>

404.1 Blocks

- a) The lengths, widths, and shapes of blocks shall be determined with due regard to: provision of adequate building sites suitable to the special needs of the type of use contemplated; zoning requirements; needs for vehicular and pedestrian circulation; control and safety of street traffic; limitations and opportunities of topography; and convenient access to water areas.
- b) Blocks shall have sufficient width to allow two (2) tiers of lots of minimum depth except where single tier, lots are required to separate residential development from through vehicular traffic or another type of use, in nonresidential subdivisions, or where abutting a water area.
- c) Where deemed necessary by the Administrator, a pedestrian crosswalk at least fifteen (15) feet in width may be required to provide convenient public access to a public area such as a park or school, to a water area, or to areas such as shopping centers, religious or transportation facilities.

404.2 Lots

- a) All lots in new subdivisions, shall conform with the dimensional requirements contained in the Town of Turkey Zoning Ordinance.
- b) Lots shall meet any applicable Sampson County Health Department Requirements.
- c) Double frontage lots shall be avoided wherever possible.
- d) Side lot lines shall be substantially at right angles to or radial to street lines.
- 404.3 Easements

Easements shall be provided as follows:

a) Utility Easements

Easements for underground or above ground utilities shall be provided, where necessary, across centered on rear or side lot lines and shall be at least fifteen (15) feet wide for water and sanitary sewer lines and as required by the companies involved, for telephone, gas and power lines. The Administrative Officer will determine whether one (1) easement is sufficient or whether several easements are necessary to accommodate the various facilities and the subdivider shall provide the required easements.

b) Drainage Easements

Where a subdivision is traversed by a stream or drainage way, an easement shall be provided conforming with the lines of such stream and of sufficient width as will be adequate for the purpose of drainage.

Section 405. Streets

405.1 Design Standards

The design of all streets and roads within the jurisdiction of this ordinance shall be in accordance with the accepted policies of the North Carolina Department of Transportation, Division of Highways, as taken or modified from the American Association of State Highway Officials (AASHO) manuals. The N.C. Department of Transportation, Division of Highways' Subdivision Road Minimum Construction Standards, July 1, 1979 or as revised and updated by NCDOT, shall apply for any items not included in this ordinance, or where stricter than this ordinance.

- 405.2 Other Requirements
- a) Through Traffic Discouraged on Residential Collector and Local Streets.

Residential collector and local streets shall be laid out in such a way that their use by through traffic will be discouraged. Streets shall be designed or walkways dedicated to assure convenient access to parks, playgrounds, schools, or other places of public assembly.

b) Sidewalks

Sidewalks may be required by the Town Board on one or both sides of the street in areas likely to be subject to heavy pedestrian traffic such as near schools and shopping areas, Such sidewalks shall be constructed to a minimum width of five (5) feet, and shall consist of a thickness of four (4) inches

of concrete. All sidewalks shall be placed in the right-of-way, unless the development is plated as a planned unit or group development. Sidewalks shall consist of a minimum of six (6) inches of concrete at driveway crossings.

c) Street Names

Proposed streets which are obviously in alignment with existing streets shall be given the same name. In assigning new names, duplication of existing names shall be avoided and in no case shall the proposed name be phonetically similar to existing names in the town or its planning area irrespective of the use of a suffix such as street, road, drive, place, court, etc. Street names shall be subject to approval of the Town Board or County E911 system..

d) Street Name Signs

The Town shall provide and erect street name signs at all intersections within the subdivisions.

e) Permits for Connection to State Roads

An approved permit is required for connection to any existing state system road. This permit is required prior to, any construction on the street or road. The application is available at the office of the nearest district engineer of the Division of Highways.

f) Wheelchair Ramps

In accordance with Chapter 136, Article 2A, Section 136-44.14, all street curbs in North Carolina being constructed or reconstructed for maintenance procedures, traffic operations, repairs, correction of utilities, or altered for any reason, shall provide wheelchair ramps for the physically handicapped at all intersections where both curb and gutter and sidewalks are provided and at other major points of pedestrian flow.

Section 406 <u>Utilities</u>

406.1 <u>Utilities</u>

a)	Public Water and Sewer Systems. All subdivisions developed within the municipal boundaries of the Town of Turkey, shall be required to connect to the public water and/or sewer system. Where public water and/or sewer systems are to be installed as part of the subdivision improvements, such systems shall be designed and installed in accordance with the standards and specifications of the health department and/or the governmental agency responsible for the approval of such systems.
b)	Tap-on Stub-Outs. Where public water and/or sewer systems are to be installed as part of the subdivision improvements, such systems shall be constructed to provide tap-on stub-outs for each lot plotted in the subdivision.
c)	On-site Water and Sewer Systems. Prerequisite to final plat approval, all lots on the plat to be recorded must be certified in writing by the health department to meet health department minimum standards for on-site water and/or sewer systems when either or both of such systems are proposed to be used.
d)	Street Lighting. Street lighting shall be provided and installed at the subdivider's expense, at intervals suggested by the appropriate electrical utility company.

406.2 Surface Water Drainage

The subdivider shall provide a surface water drainage system constructed to the standards of the North Carolina Department of Transportation, as reflected in the <u>Handbook for the Design of Highway Surface</u> <u>Drainage Structures</u>, subject to review by the Town of Turkey Consulting Engineer.

- a) No surface water shall be channeled or directed into a sanitary sewer.
- b) Where feasible, the subdivider shall connect to an existing surface water drainage system.
- c) Where an existing surface water drainage system cannot feasibly be extended to the subdivision, a surface drainage system shall be designed to protect the proposed development from water damage.
- d) Surface drainage courses shall have side slopes of at least three (3) feet of horizontal distance for each one (1) foot of vertical distance, and courses shall be of sufficient size to accommodate the drainage area without flooding, and designed to comply with the standards and specifications for erosion control of the North Carolina Sedimentation Pollution Control Act, G.S. 143-34-12, Chapter 113A, Article 4 and the North Carolina Administrative Code Title 15, Chapter 4, and any locally adopted erosion and sedimentation control ordinances.
- e) The minimum grade along the bottom of a surface drainage course shall be a vertical fall of at least one (1) foot in each two hundred (200) feet of horizontal distance.
- f) Streambanks and channels downstream from any land disturbing activity shall be protected from increased degradation by accelerated erosion caused by increased velocity of runoff from the land disturbing activity in accordance with the North Carolina Sedimentation Pollution Control Act, G.S. 143-34.12, Chapter 113A, Article 4 and the North Carolina Administrative Code Title 15, Chapter 4.
- g) Anyone constructing a dam or impoundment within the subdivision must comply with the North Carolina Dam Safety Law of 1967 and the North Carolina Administrative Code Title 15, Subchapter 2 K.
- h) In all areas of special flood hazards, all subdivision proposals shall have adequate drainage provided to reduce exposure to flood damage.

406.3 Underground utilities

The subdivider shall be required to install at his expense all electrical, telephone, and cable television service for the subdivision in an approved underground system.

Section 407. Other Requirements

407.1 Placement of Monuments

Unless otherwise specified by this ordinance, the <u>Manual of Practice for Land Surveying</u> as adopted by the N. C. State Board of Registration for Professional Engineers and Land Surveyors, under the provisions of Title 21 of the North Carolina Administrative Code, chapter 56 (21 NCAC 56), shall apply when conducting surveys for subdivisions; to determine the accuracy for surveys and placement of monuments, control corners, markers, and property corner ties; to determine the location, design, and material of monuments, markers, control corners, and proper corner ties; and to determine other standards and procedures governing the practice of land surveying for subdivisions.

407.2 Construction Procedures

No construction or installation of improvements shall commence in a proposed subdivision until the preliminary plat has been approved, and all plans and specifications have been approved by the appropriate authorities.

No building, zoning or other permits shall be issued for erection of a structure on any lot not of record at the time of adoption of this ordinance have been met. The subdivider, prior to commencing any work within the subdivision, shall make arrangements with the administrator of this ordinance to provide for adequate inspection. The approving authorities having jurisdiction or their representatives shall inspect and approve all completed work prior to release of the sureties.

407.3 Oversized Improvements

The Town of Turkey may require installation certain oversized utilities or the extension of utilities to adjacent property when it is in the interest of future development. If the Town requires the installation of improvements in excess of the standards required in this ordinance, including all standards adopted by reference, the Town shall pay the cost differential between the improvement required and the standards in this ordinance. These agreements shall be in accordance with G.S. 160D, Article 10.

ARTICLE V DEFINITIONS

Section 501. <u>Subdivision Defined</u>

For the purposes of this ordinance, "subdivision" means all divisions of, a tract or parcel of land into two or more lots, building sites, or other divisions when any one (1) or more of those divisions is created for the purpose of sale or building development (whether immediate or future) and shall include all divisions of land involving the dedication of a new street or a change in existing streets; but the following shall not be included within this definition nor be subject to any regulations enacted pursuant to this ordinance.

- a) The combination or recombination of portions of previously subdivided and recorded lots where the total number of lots is not increased and the resultant lots are equal to or exceed the standards of the municipality as shown in this ordinance;
- b) The division of land into parcels greater than ten (10) acres where no street right-of-way dedication is involved;
- c) The public acquisition by purchase of strips of for the widening or opening of streets, and for public transportation system corridors; and
- d) The division of a tract in single ownership whose entire area is no greater than two (2) acres into not more than three (3) lots, where no street right-of-way dedication is involved and where the resultant lots are equal to or exceed the standards of the municipality as shown in this ordinance.
- e) The division of a tract into parcels in accordance with the terms of a probated will or in accordance with intestate succession under Chapter 29 of the General Statutes.
- f) A GIFT LOT which is defined as a parent making a one-time gift to his/her child of a parcel of land divided from the parent's property with proper access of at least 25 feet along a public right-of-way and which otherwise meets the zoning lot requirements for the district the lot is located in.

Section 502. Other Definitions

For the purpose of this ordinance, certain words or terms used herein shall be defined as follows:

<u>Administrative decision</u> Decisions made in the implementation, administration, or enforcement of development regulations that involve the determination of facts and the application of objective standards set forth in this ordinance. These are sometimes referred to as ministerial decisions or administrative determinations.

Administrative hearing A proceeding to gather facts needed to make an administrative decision.

Block A piece of land bounded on one or more sides by streets or roads.

<u>Building Setback Line</u> A line parallel to the front property line in front of which no structure shall be erected. Setbacks shall be figured from the right-of way line.

<u>Comprehensive plan</u> A comprehensive plan that has been officially adopted by the Board of Commissioners pursuant to G.S. 160D-501.

<u>Decision-making board</u> A governing board, planning board, board of adjustment, historic district board, or other board assigned to make quasi-judicial decisions under this ordinance.

<u>Dedication</u> A gift, by the owner, or a right to use of land for a specified purpose or purposes. Because a transfer of property rights is entailed, dedication must made by written instrument, and is completed with an acceptance.

<u>Determination</u> A written, final, and binding order, requirement, or determination regarding an administrative decision.

<u>Developer</u> A person, including a governmental agency or redevelopment authority, who undertakes any development and who is the landowner of the property to be developed or who has been authorized by the landowner to undertake development on that property.

Development Any of the following:

(A) The construction, erection, alteration, enlargement, renovation, substantial repair, movement to another site, or demolition of any structure.

(B) The excavation, grading, filling, clearing, or alteration of land.

(C) The subdivision of land as defined in G.S. 160D-802.

(D) The initiation or substantial change in the use of land or the intensity of use of land.

<u>Development approval</u> An administrative or quasi-judicial approval made pursuant to this ordinance that is written and that is required prior to commencing development or undertaking a specific activity, project, or development proposal. Development approvals include, but are not limited to, zoning permits, site plan approvals, special use permits, variances, and certificates of appropriateness. The term also includes all other regulatory approvals required by regulations adopted pursuant to this ordinance, including plat approvals, permits issued, development agreements entered into, and building permits issued.

<u>Development regulation</u> A unified development ordinance, zoning regulation, subdivision regulation, erosion and sedimentation control regulation, floodplain or flood damage prevention regulation, mountain ridge protection regulation, stormwater control regulation, wireless telecommunication facility regulation, historic preservation or landmark regulation, housing code, State Building Code enforcement, or any other regulation adopted pursuant to this ordinance, or a local act or charter that regulates land use or development.

Easement A grant by the property owner of a strip of land for a specified purpose and use by the public, a corporation, or persons.

<u>Evidentiary hearing</u> A hearing to gather competent, material, and substantial evidence in order to make findings for a quasi-judicial decision required by a development regulation adopted under this ordinance.

<u>Governing board</u> The Town of Turkey Board of Commissioners. The term is interchangeable with the terms "board of aldermen" and "boards of commissioners" and means any governing board without regard to the terminology employed in charters, local acts, other portions of the General Statutes, or local customary usage.

<u>Half Street</u>. A street whose centerline coincides with the subdivision plat boundary, with one-half (1/2) the street right-of-way width being contained within the subdivision plat. Also, any existing street to which the parcel of land to be subdivided abuts on only one side.

Lot A portion of a subdivision, or any other parcel of land, intended as a unit of transfer of ownership or for development or both.

Lot of Record A lot which is part of a subdivision, a plat of which has been recorded in the office of Register of Deeds of Sampson County prior to the adoption of this ordinance, or a lot described by metes and bounds, the description of which has been so recorded prior to the adoption of this ordinance.

Lot Types:

<u>Corner Lot</u> A lot located at the intersection of two or more streets. A lot abutting on a curved street or streets shall be considered a corner lot if straight lines drawn from the foremost points of the side lines to the foremost point of the lot meet at an interior angle of less than one hundred thirty-five (135) degrees.

Double Frontage Lot A continuous (through) lot which is accessible from both streets upon which it fronts.

Interior Lot A lot other than a corner lot with only one frontage on more than one street.

<u>Through Lot or a "Double Frontage Lot"</u> A lot other than a corner lot with frontage on more than one street. Through lots abutting two streets may be referred as double frontage lots.

<u>Reversed Frontage Lot</u> A lot on which the frontage is at right angles or approximately right angles (interior angles less than one hundred thirty-five (135) degrees) to the general pattern in the area. A reversed frontage lot may also be a corner lot, an interior lot or a through lot.

Single Tier Lot A lot which backs upon a limited access highway, a railroad, a physical~ barrier, or another type of land use and to which access from the rear is usually prohibited.

Official Maps or Plans Any maps or plans officially adopted by the Turkey Town Board of Commissioners.

<u>Open Space</u> An area (land and/or water) generally lacking in man-made structures and reserved for enjoyment in its unaltered state.

<u>Person</u> An individual, partnership, firm, association, joint venture, public or private corporation, trust, estate, commission, board, public or private institution, utility, cooperative, interstate body, the State of North Carolina and its agencies and political subdivisions, or other legal entity.

<u>Planning and development regulation jurisdiction</u> The geographic area defined in Part 2 G.S. 160D within which the town may undertake planning and apply the development regulations authorized by this ordinance.

<u>Plat</u> A map or plan of a parcel of land which is to be, or has been subdivided.

<u>Public Water System</u>. A system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.

<u>Public or Community Sewage System</u>. A single system of sewage collection, treatment, and disposal owned and operated by a sanitary district, a metropolitan sewage district, a water and sewer authority, a county or municipality, or a public utility.

<u>Private Driveway</u>. A roadway serving two (2) or fewer lots, building sites or other division of land and not intended to be public ingress or egress.

<u>Private Street</u> An undedicated private right-of-way which affords access to abutting properties and requires a subdivision streets disclosure statement in accordance with G.S. 136-102.6.

<u>Quasi-judicial decision</u> A decision involving the finding of facts regarding a specific application of a development regulation and that requires the exercise of discretion when applying the standards of the regulation. The term includes, but is not limited to, decisions involving variances, special use permits, certificates of appropriateness, and appeals of administrative determinations. Decisions on the approval of subdivision plats and site plans are quasi-judicial in nature if the regulation authorizes a decision-making

board to approve or deny the application based not only upon whether the application complies with the specific requirements set forth in the regulation, but also on whether the application complies with one or more generally stated standards requiring a discretionary decision on the findings to be made by the decision-making board.

<u>Reservation</u>. A reservation of land does not involve any transfer of property rights. It simply constitutes an obligation to keep property free from development for a stated period of time.

<u>Septic Tank System</u> A ground absorption sewage treatment and disposal system consisting of a septic tank and a nitrification field, necessary pipe lines, conduits, pump stations, and other appurtenances required for proper collection, distribution, treatment, disposal, operation and performance, or any other system approved by the Health Department.

<u>Street</u>. A dedicated and accepted public right-of-way for vehicular traffic (or a private road only if permitted by this ordinance). The following classifications shall apply.

<u>Principal Arterial</u> A rural link in a network of continuous routes serving corridor movements having trip length and travel density characteristics indicative of substantial statewide or interstate travel and existing solely to serve traffic. This network would consist of interstate routes and other routes designed as principal arterials.

<u>Minor Arterial</u> A rural link in a network joining cities and larger towns and providing intrastate and intercounty service at relatively high overall travel speeds with minimum interference to through movement. This network would primarily serve traffic.

<u>Major Collector</u> A road which serves major intracounty travel corridors and traffic generators and provides access to the arterial system.

<u>Minor Collector</u> A road which provides service to small local communities and links locally important traffic generators with their rural hinterland.

Local Road/Street A local road serves primarily to provide access to adjacent land and for travel over relatively short distances.

Specific Type Rural or Urban Streets

<u>Freeway Expressway or Parkway</u> Divided multilane roadway designed to carry large volumes of traffic at relatively high speeds. A <u>freeway</u> is a divided highway providing for continuous flow of vehicles with no direct access to abutting property or streets and with access to selected crossroads provided via connecting ramps. An <u>expressway</u> is a divided highway with full or partial control of access and generally with grade separation major intersections. A <u>parkway</u> is a highway for noncommercial traffic, with full or partial control of access, and usually located within a park or a ribbon parklike development.

<u>Residential Collector Street</u> A local access street which serves as a connector street between local residential streets and the thoroughfare system. Residential collector streets typically collect traffic from 100 to 400 dwelling units.

Local Residential Street. Cul-de-sacs, loop streets less than 2,500 feet in length, or streets less than one mile in length that do not connect thoroughfares, or serve major traffic generators, and do not collect traffic from more than 100 dwelling units.

<u>Cul-de-sac</u> A short street having but one end open to traffic and the other end being permanently terminated and a vehicular turnaround provided.

<u>Frontage Road</u> A local street or road that is parallel to a full or partial access controlled facility and functions to provide access to adjacent land.

<u>Alley</u> A strip of land, owned publicly or privately set aside primarily for vehicular service access to the back or side of properties otherwise abutting on a street.

<u>Subdivider</u> Any person, firm, or corporation who subdivides or develops any land deemed to be a subdivision herein defined.

<u>Subdivision</u> Per G.S. 160D-102, the division of land for the purpose of sale or development as specified in G.S. 160D-802.

<u>Vested right</u> Per G.S. 160D-102, the right to undertake and complete the development and use of property under the terms of an approval secured as specified in G.S. 160D-108 or under common law.

Section 503. Word Interpretation

For the purpose of this ordinance, certain words shall be interpreted as follows:

Words used in the present tense include the future tense. Words used in the singular number include the plural and words used in the plural number include the singular, unless the natural construction of the wording indicates otherwise.

The word "person" includes a firm, association, corporation, trust, and company as well as an individual.

The word "use for" shall include the meaning "designed for".

The word "structure" shall include the word "building".

The word "lot" shall include the words "plot", "parcel" or "tract".

The word "shall" is always mandatory and not merely directory.
